Credit Verification (Institution):
1) Certification cards and certificates are available electronically. A certificate reflecting active certifications can be printed or emailed. Certifications can be verified online with a certification number at services.dps.ohio.gov/EMSProviders/Verification . 2) Individuals may have either electronic or paper certificates reflecting their certification level and bearing a Pro Board seal. Pro Board certificates or certifications with a Pro Board seal can be verified online with last name and PIN at certificationsearch.theproboard.org/ . 3) Individuals may have either electronic or paper certificates reflecting their certification level and bearing an IFSAC seal. IFSAC provides information on ways to verify an IFSAC seal at ifsac.org/ifsac-seal-verification . Typically, the fastest way is to contact the entity that issued the certification, many of whom have online certification verification systems.
Credit Verification (Student):
To receive credit, provide your institution with their preferred form of proof of your certification, including any personal identification numbers needed to verify your certification. Student credentials should be provided to MVTPC office along with student's permission to post either by bulk upload through Tech Prep Portal or individually at www.mvtechprep.org .
Additional Requirements for Credit:
1) Certification must be current 2-3) Standard Edition Date to which the individual is certified must not be prior to 2019. Non-Ohio Firefighter II certification with Pro Board® or IFSAC seal is eligible for academic credit; however, to provide firefighting services, current Ohio Firefighter certification is required.
